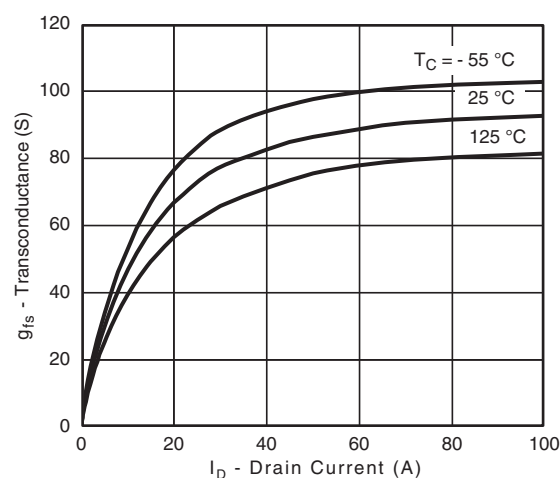
Source Drain Diode Forward Voltage



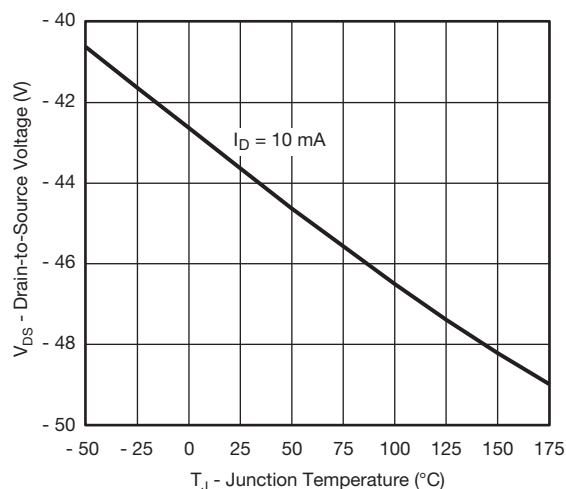
On-Resistance vs. Gate-to Source Voltage



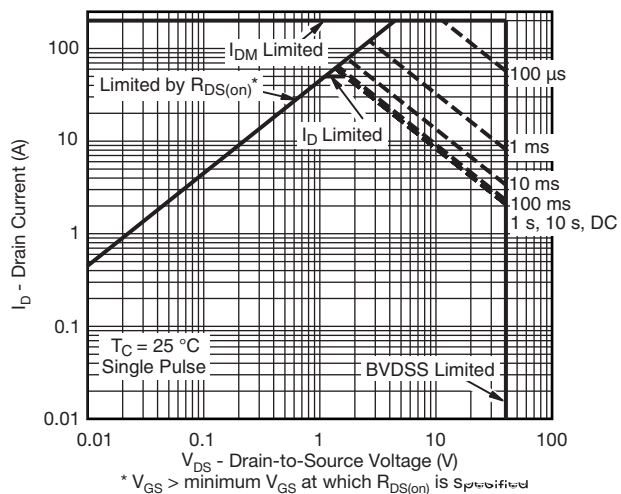
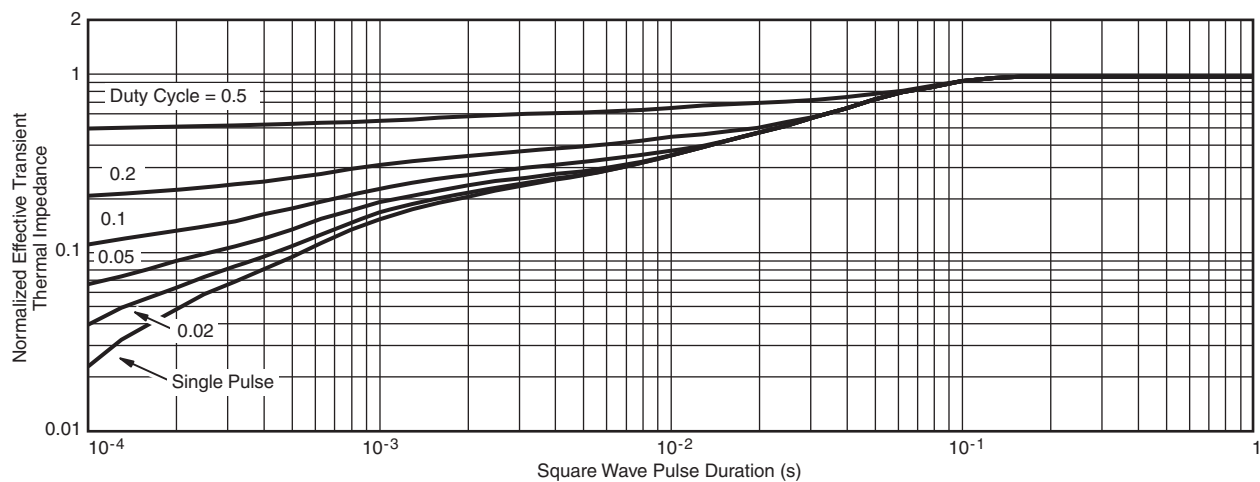

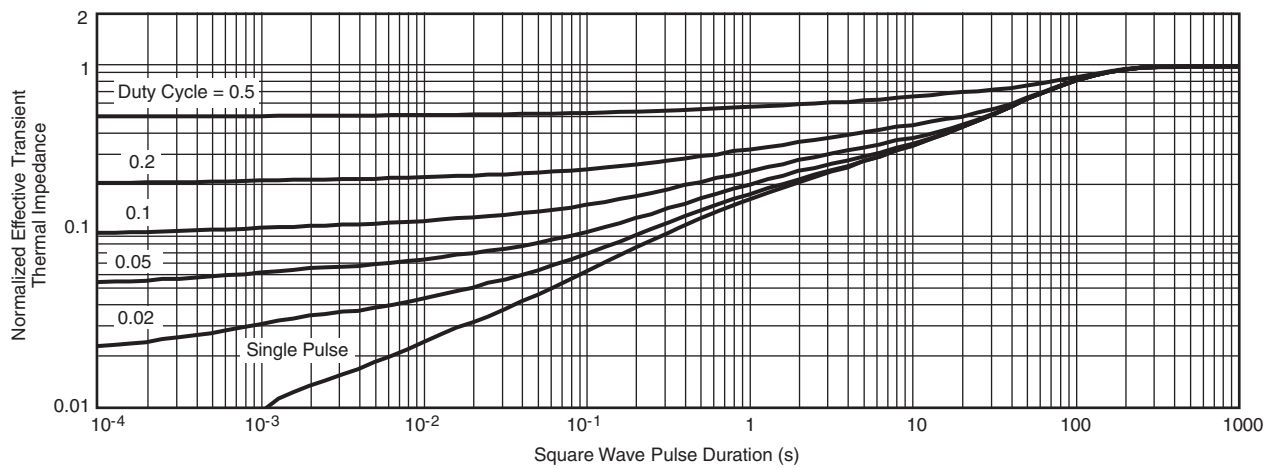

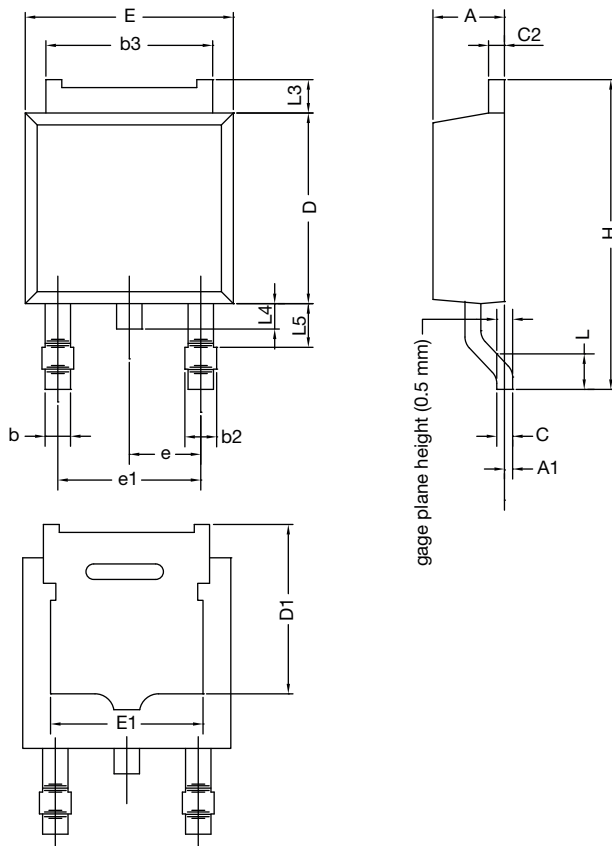


**Normalized Thermal Transient Impedance, Junction-to-Ambient**

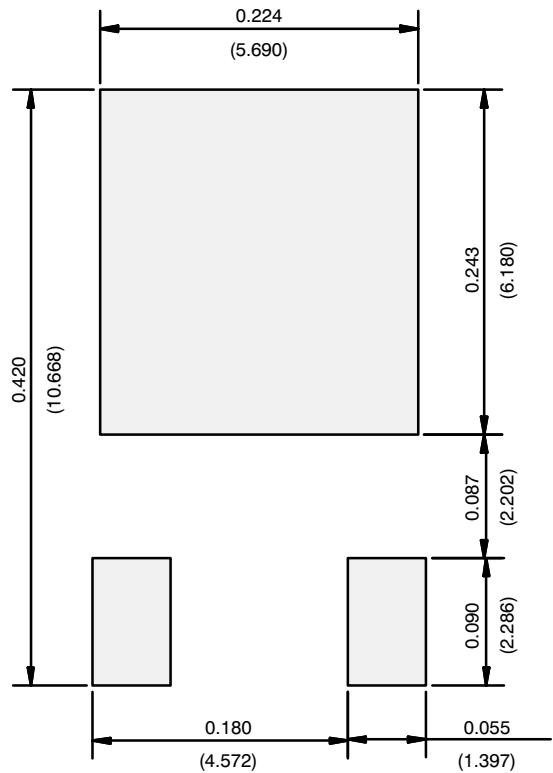
